## MACHINE TERMS & CONDITIONS



- 1. THE Client will, during the period of the hiring, be responsible for the supervision of the equipment (unless operator is provided by Claire's Candy Hire), its care, safety from damage however slight or change of any sort. The client acknowledges that he / she has read and understands any relevant operating and safety instructions supplied with the equipment. Claire 's Candy castles Hire excludes any liability for injury loss or damage caused to any person using the equipment contrary to the terms and conditions of this Contract. Claire's Candy Castles Hire excludes any liability for any allergies and physical reactions caused by any products, food and items use in hire contracts.
- 2. IN ALL HIRING CONTRACTS the client and operator of the equipment must be of the age of 18 or above .
- 3. IN ALL HIRING CONTRACTS a late returns fee is charged every 24 hours over the agreed return date. Late returns fee charged at the following rates.£40 per every 24 hours for the first 24 hours then a further charge of £50 per 24 hours + lose of booking there after unless a new agreement between Claire's Candy Hire and the Client has been put in place before the end of the Previous agreement ends.
- 4. THE Client shall not use the equipment for any purpose other than that described in the hiring agreement, and shall not sub hire or use the equipment or allow the equipment to be used for any unlawful purpose or in any unlawful way, nor allow anyone onto the equipment with unsuitable dress or unsuitable protection if needed. No food or drink is to be consumed on/ near the equipment. The hirer should not use the equipment outside in the event of high winds or wet conditions, the hirer must locate the equipment on a flat table or worktop and satisfy their self that the equipment is safe and steady at all times.
- 5. THE Client is required to supply a working 13amp plug and a suitable and safe place for the working of equipment, all persons is recommended to stand back from equipment with the exception of the operator. PUBLIC LIABILITY INSURANCE is included in its entirety any equipment used in a licenced place i.e., pub, social club etc Will not operate the equipment after 8pm. It is the Client responsibility to make sure that nobody uses the equipment with out sufficient training or supervision and NOT TO USE under the influence of alcohol and/or drugs or with unstable ingredients (I.E food colouring / dye, wrong sugar, adding water ect.) ANY use of the equipment used in a licenced place i.e., pub, social club

- etc. after 8pm will not be covered by insurance and make the client liable and will not be able to make a claim against Claire's Candy Hire.
- 6. IN ALL HIRING CONTRACTS the client is required to produce a valid name and address and 2 forms of I.D
- 7. THE Client shall be deemed to have inspected the equipment, (accessories and extra(s) if supplied) and to have agreed that it is supplied in good condition unless they bring to the attention of Claire's Candy Hire at time of delivery. Any fault not reported will be deemed to be the responsibility of the client. The client accepts how the equipment is setup and is Happy.
- 8. IF THE Client wishes to cancel the booking for whatever reason, please notify Claire's Candy Hire within 24 hours of the expected hire date.
- IN THE EVENT of an accident occurring, full written details
  must be recorded including, name and address of injured
  party, circumstances of accident, date and place of incident
  and a copy of the report to be sent to Claire's Candy Hire.
- AT THE END of the hiring the Hirer shall be responsible for leaving the equipment in a undamaged & tidy condition "DO NOT CLEAN THE MACHINES" just remove any mess or debris not coursed by the machine otherwise the client shall be liable to make an additional charge of for cleaning of the equipment or if unstable ingredients are used a £30 charge will apply (contact Claire candy for more information on unstable products or ingredients) In the event of damage to the equipment the client will be charged for the repair or replacement. Damages price start from £50 per item unless rendered unfit for use + lose of booking. In the event of the equipment or any part there of being rendered unfit for the use for which it has been hired, Claire's Candy Hire shall not be liable to the client for any resulting loss or damage what so ever. No refunds will be made until the equipment is returned and tested and deemed unusable, payment will be in relation to items, products, food stocks remaining and will be entirely at the discretion of Claire candy Hire. Any continued use of any equipment after reporting any fault or problem will result in No Refund.
